- The nation's oldest continuous open water swimming race dating back to 1929
- Distance of approximately 1.5 miles - from States Ave., swimmers proceed through the surf, around Steel Pier and in a southwesterly direction to Missouri Ave. finish on the beach
- Race day registration at States Ave. Lifeguard Station ( in front of the Showboat Casino ) 8 - 9:30am
- Long-sleeved T-shirts to all pre-registered swimmers and available to all race day registrants while they last
- No limit on the number of swimmers
- Course is set - will not change due to conditions
- One bag per swimmer will be transported to the finish area
- No refunds due to postponement
- Wet suits are not permitted
- Entry Fee:                     Pre-registered \$20 - prior to 8 - 28 - 2008  
  Post-registered \$25 - from 8 - 28 - 2008 through race day
- Awards: 1st, 2nd, & 3rd place overall, male and female, will receive distinctive awards.
- Ribbons for top three males and females in the following age groups:  
    1 - 12      13 - 14      15 - 16      17 - 19      20 - 29      30 - 39      40 - 49      50 - 59      60 - 69      70 & Over
